Safe Boating Through Education

From The Commander Cdr Dick Howells, JN



We are closing in on the end of what has been a busy and difficult year for our Squadron. Our membership numbers have held in the face of difficult times and declining national interest in the United States Power Squadrons. Nationally, membership is below 35,000. To have held our own is remarkable.

We have 2 major events left for this bridge: our annual meeting Saturday 24 Oct 09 and the Squadron Change of Watch Saturday 21 Nov 09. Because we are hosting the District 26 Change of Watch the first weekend in October, the Executive Committee decided to combine our annual meeting with our oyster roast fund raiser. There will not be a meeting on the 2d Thursday of October.

At the annual meeting, we elect the new bridge and executive committee for 2010. To be clear, you may attend the meeting and vote if you do not wish to donate to the fund raiser and eat. Because we will have guests at the meeting we will give active (voting) members a colored card to indicate that they may cast a vote. We will hold the meeting at around 1700 and then start on the food afterwards to accommodate those members who do not wish to pay for the Oyster Roast.

In accord with Article II of our bylaws, the slate of candidates from the nominating committee will be placed in nomination by a seconded motion from the floor. A simple majority vote of a membership quorum present serves to elect all of those nominated. Any vacancies that were not filled or nominated by the committee may be filled from the floor.

There are provisions in Article II for contested nominations and I would draw your attention to the bylaws for those. If you do not have the bylaws, call me and I will tell you how to obtain them from the national site.

Administrative Officer is one of the most demanding positions in the squadron. The Administrative Department is responsible for the internal operation of the squadron. This includes boating activities, monthly meetings, and membership recruiting and member involvement. This year's nominee for Administrative Officer is Bill Hayes. Bill is a relatively new member to our squadron, but not new to boating. He has worked as a professional fishing guide, is an experienced off-shore sailor and has served as a crew member for long-distance off-shore sail boat races. Since joining our squadron, Bill has volunteered for squadron work on many occasions, including the recent Squadron Clean-up day. Bill has become the-person-to-go-to when the squadron needs someone who can get things done.

Our membership Chairman, Wendy Walsh, has been very active lately. She has made it a point to attend our America's Boating Course, promote Squadron membership and tirelessly follow up on potential member leads. She reports that the new offering of the Squadron's Piloting Course for non-members has been a successful recruiting tool. Of the five non-members who signed up for the Piloting Course, all five have now joined the squadron.

October is a busy month for the squadron. Charleston is hosting the District 26 Change of Watch. This event is an excellent chance for all Charleston Squadron members to participate in seminars, social events and the formal Change of Watch. On Friday 2 October 2009 a series of seminars is being offered by D26 Officers and staff. One seminar that you don't want to miss is the Squadron Leadership Seminar being given by our own Past Commander Ed Kridler. The Leadership Seminar starts at 1130 in Edisto Hall at the James Island County Park. At 1300, also at Edisto Hall, will be a Sales Training Seminar that gives us information on how to market USPS educational courses to the public. A Seminar on the USPS

Boater Certification program will be held at Squadron Headquarters on Friday at 1300. These seminars are free and of great interest to squadron members. Please plan to attend at least one of these seminars.

Our Annual Meeting and Oyster Roast will be held on Saturday 24 October 2009. As in the past, the Oyster Roast will be at the Wichmanns' home, Toad Hall on James Island. The cost is \$20 per person for all-you-can-eat oysters, hotdogs and burgers. Side dishes will be pot-luck. Please bring a dish to share. This year we are combining the Oyster Roast with our Annual Meeting and Election of Officers. Members are strongly encouraged to attend this event. Remember, this is our only major fund-raising event. So please plan to attend and bring lots of your friends to share in this excellent eat-out.

The Charleston Sail and Power Squadron's Change of Watch ceremony is scheduled for 21 November 2009 aboard the Yorktown at Patriot's Point. This is the last function of the 2009 Squadron Bridge and the only formal event of the squadron year. The ceremony involves installation of the new 2010 Bridge Officers and presentation of awards earned by our members in 2009. So, please mark your calendar for this event and plan to attend.
