SAFE BOATING THROUGH EDUCATION

From the Commander Cdr David Walsh, AP



he United States Power Squadron's Annual Meeting is 24 February 2007 in Jacksonville, FL. This year marks the 93rd Anniversary of the founding of the USPS. Over the years, USPS has changed to meet challenges of technology and of the times. Back 93 years ago, pleasure boats were mostly wind and steam powered and the USPS was an "all boys" club. A "high powered" outboard motor generated, perhaps, 10 horse power, if you could get it started. Well, recreational boating and USPS have come a long way. Today we have outboards topping 300 horse power, steam powered recreational boats are considered museum-pieces and 2007 marks the 25th Anniversary of elective membership of women in the USPS. To celebrate, USPS will be issuing a commemorative plaque acknowledging 25 years of full membership for women. Considering their achievements and contribution to the organization, it is hard to think of the Power Squadron existing without women in its leadership. So let's celebrate USPS's 93rd Anniversary and most importantly, the last 25 years.

New initiatives are presented each year at the USPS Annual Meeting. This year the new USPS Boat Operator Certification Program will make its debut. The program has four levels of certification: Inland Pilot, Coastal Pilot, Advanced Coastal Pilot and Offshore Navigator. Each level of certification requires applicants to pass certain USPS courses and demonstrate proficiency. Chet Rogers, Charleston's Educational Officer, will be reporting on this important new certification program in the coming months.

A major USPS initiative is Cooperative Charting's Adopt-A-Chart program. For those who are new to the squadron, Adopt-a-Chart is an organized comprehensive effort to update specific charts and to keep them up-to-date on an ongoing basis. The National Ocean Service (NOS) is a Federal agency responsible for keeping Nautical Charts up-to-date. USPS assists NOS by submitting Nautical Chart Corrections. Several years ago, the Charleston Power Squadron "adopted" Charts 11518 and 11522. Charleston Power Squadron's Cooperative Charting chairman Steve Kromer will be coordinating the squadron's charting activities with the USPS national program.

Another USPS initiative is National Safe Boating Week, 19-26 May 2007. Squadron Public Relations Officer, Gary Whitley, will be placing ads and promoting safe boating during this week. Included are professionally prepared USPS radio and TV messages about safe boating and newspaper announcements of the Charleston Squadron's BoatSmart course schedule.

Two Charleston Squadron boats will be making the trip to the 2007 USPS Annual Meeting in Jacksonville, FL. Art and Merle Clark will be taking their boat "Sunday Drive." Wendy Walsh and I in our boat "Reely Fun" will convoy with the Clarks. We expect to leave on Tuesday 20 February and arrive on time to participate in the USPS Annual Meeting on Saturday 24 February. Art and I are squadron engine maintenance instructors. So, you can bet our boats are expertly prepared for the Florida run. However, as boaters know, anything can and usually happens. So wish us fair winds and luck on our voyage to the National Meeting in Jacksonville.

Designated Driver Not Enough, Study Warns

Well-intentioned programs that encourage the use of a designated operator aren't going to make much of a dent in the numbers of alcohol-related boating deaths, a research team has warned. The reason: A passenger who consumes alcohol on board is just as likely to die as an operator who is drinking, say researchers at the University of North Carolina and Johns Hopkins University.

Their conclusion, published in the Journal of the American Medical Association, is based on a study of 221 boating deaths in North Carolina and Maryland between 1990 and 1998. People who are drinking often fall overboard and drown, the study found. And that can happen even if the boat is stationary, the researchers say, pointing to the death of Hollywood star Natalie Wood 25 years ago.

"People often assume that alcohol-related boating accidents involve a collision," said Dr. Robert D. Foss, research scientist at the UNC Highway Safety Research Center. "That happens, of course, but most deaths result from drowning – often when boats aren't moving at all."

The team said about 80 percent of fatalities result from drowning.

The image of the crazed drunken boater ramming into a dock or another boat is "a pretty rare phenomenon," Foss said. "If you've got a stone-cold sober boat operator and an impaired passenger, that passenger is still at high risk."

The research teams studied boating fatality records from medical examiners, and spent three summers interviewing and obtaining breath alcohol measurements from boaters in both states.

Alarmingly, the study finds it doesn't take much alcohol to bring about impairment. Even with a blood alcohol content of only .01 percent, the risk to operators and passengers increased 30 percent, Foss said. The risk of death was more than 52 times greater when victims showed a blood alcohol content of .25 milligrams per deciliter, he said.

"Before we did the study, we had a fairly good idea about the risk curve for drinking drivers on the road, but we had no idea about the risk for boaters who had been drinking," Foss said. "This study gives us the first look at the shape of the risk curve for boaters."

The study was supported by the National Institute on Alcohol Abuse and Alcoholism.

The program is easy to navigate, accepts digital photographs, lists dates and prices for items purchased and can be updated easily. What is a Vessel Safety Check? On the web go to SafetSeal.net and then click on "Virtual VSC"; this site goes into detail on the 15 items that must be passed to earn the VSC Decal for 2007. The items covered by the VSC include:

- -Display of Numbers (If registered need a space between letters and numbers)
- -Registration / Documentation (Papers must be on boat) -Personal Flotation Device (Need one serviceable PFD for each person on board)
- -Visual Distress Signals (Must be current, not expired)
- -Fire Extinguishers (Must be serviceable and appropriate number based on length)
- -Ventilation (Boats with inboard gas engines require operating blower)
- -Backfire Flame Control (Boats with gas engines require clean device)
- -Sound Producing Device (Must work, can be an air horn)


- -Navigation Lights (All must work to include anchor light)
- -Pollution Placard (Required if over 26 feet, VE can normally provide)
- -MARPOL Trash Placard (Required if over 26 feet, VE can normally provide)
- -Marine Sanitation Device aka Head (Overboard discharge must be controlled)
- -Navigation Rules (Required if over 39.4 feet)
- -State and Local Requirements (Must have Factory Installed Muffler)

SC requirements at: boater101.com/Course/documents/SC/SCstatelaws.pdf

Overall Vessel Condition

- -Deck free of hazards and clean bilge
- -Safe Electrical and Fuel Systems (Batteries must be secured)
- -Safe Galley and Heating Systems (No flammable material next to stove).

Most problems are found with: Dated Flares, Inoperative Fire Extinguishers and Inoperative Navigation Lights. The above items in parenthesis are only some of the items check under each of the 15 major topics; visit the "Virtual VSC" for a complete list of items check during the VSC.
